APPLICATION INSTRUCTIONS

SUBSTRATE PREPARATION

Ensure surfaces to which tape is to be applied are clean sound and dry. Remove outer packaging from roll of tape.

APPLICATION METHOD / TOOLS

Peel required amount of tape from roll pressing firmly into place while unrolling. Cut with a knife or tear off when finished.

LIMITATIONS

- Do not use on surfaces that bleed oils or plasticiser.
- Do not use below 10°C as tack will be reduced significantly.
- It is the users responsibility to determine suitability for use. If in doubt contact technical services for advice
